Probable Cause Affidavit

Before me this date personally appeared ROGER P. HAGER who being first duly sworn deposes (crime location) the above named and says that on 31 Day of: JUL (year) 03 at 4641 NE 3RD TERRACE FT. LAUD. defendant committed the above offenses charged and the facts showing probable cause t believe the same are as follows:
The defendant Kenneth Wilcox rented a furnished residence located at 4641 NE 3rd Terrace from the victim Gary Bastian sometime back in June 2003. The defendant Wilcox moved a roommate Heather Stanton in with him. The defendant Wilcox was notified by the victim Bastian's attorney that he needed to vacate the residence by July 31, 2003 due to lack of payment, or face eviction. The roommate stanton moved out in mid July 2003, and stated that all of the victim's furniture was still there. The defendant Wilcox moved out of the residence on July 31st 2003. After the defendant moved out of the residence, the victim found that numerous items of his furniture was missing from the home. Prior to checking the home it was found to be secure, and there were no signs of forced entry. The furniture missing totaled approximately \$3,200.00. The defendant Wilcox later said that Bastian's furniture was loaned to friends of his and Stanton's without permission from the victim Bastian. The residence was rented to the defendant Wilcox through a verbal agreement, therefore he was responsible for the property inside. No one else had access to the home during this time period except the defendant Wilcox and his roommate Heather Stanton. The furniture taken from the residence was never returned, thus depriving the victim Bastian of his property valued at \$3,200.00.
