Before me this date personally appeared Baranyai, Kelly 5765 who being first duly sworn deposes and says that on 01 day of January, 2004 year, at 2700 block NE 8th Ave Wilton Manors Florida (the location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:  
an apartment complex located at the listed location. Sgt. Chadwick contacted subject and observed his eyes to be glassy and bloodshot, a slurred speech with an odor of alcohol on his breath. Subject staggered as he walked around outside of his vehicle. Upon asking for subject's DL, registration and insurance, subject fumbled and dropped several pieces of paperwork. Subject failed to locate his DL. Subject gave the name of Russel M. Wilcox with a DOB of 08-31-69 to Sgt. Chadwick.

I contacted subject who was standing to the rear of his vehicle. Subject swayed from front to back as he stood. I advised subject that I was conducting a DUI investigation. I asked subject if he was currently taking any medication, had any medical illnesses or injuries. He advised he takes Xanax .05mg for anxiety and Endocrine for a heart condition. Subject advised he consumed two Xanax today. I could smell an odor of alcohol emitting from within his breath, his speech was slurred and he had glassy, bloodshot eyes. I asked subject if he consumed any alcoholic beverages. He advised he had 3 cocktails at a party down the street. The cocktails were Vodka mixed with cranberry. Subject advised me he was a doctor of psychology and worked at the Department of Family Services within the Broward Sheriff's Office. Subject advised me his name was Russell McKinnon Wilcox with a DOB of 08-31-69. I asked subject if he would submit to a few roadside sobriety exercises. He agreed. The following exercises were conducted in the parking lot of the listed location which is a flat, blacktop surface, lit by my vehicle's headlights. The walk and turn exercise was conducted on a white permanent parking space marker.
